Economic Forecast and Building BC Awards

The Chamber was excited to host our Economic Forecast and Building BC Awards, where we celebrated the UHS Wilson Tower and Victory Lofts projects. We also heard valuable housing updates from Alison Donnelly, Executive Officer of the Greater Binghamton Association of Realtors, and enjoyed a healthcare panel featuring Lourdes President & CEO Kathy Connerton, UHS President & CEO John Carrigg, and Guthrie CEO Dr. Edmund Sabanegh, Jr.



Annual Labor & Employment Law Update

The Greater Binghamton Chamber of Commerce hosted its 36th Annual Labor and Employment Law Update, in partnership with Hinman, Howard, & Kattell, LLP. The event covered a range of important topics, including artificial intelligence, the New York Clean Slate Act, workplace harassment, wage and hour laws, workers' compensation, and remote work.

Upstate United

The Chamber worked closely with Upstate United to develop effective strategies to improve our advocacy efforts, build bi-partisan relationships and advance our legislative priorities.

Engaging Electeds

The Chamber held the second annual summer soiree where business owners had the opportunity to enjoy a beautiful summer evening of networking with other industry professionals and the members of our local, state, and federal delegation.



Legislative Breakfast

The Chamber hosted its 7th annual Legislative Breakfast featuring keynote speaker Kevin Lanahan, President of External Affairs & Corporate Communications with the New York Independent System Operator (NYISO). Kevin presented on the impacts of the Climate Leadership and Community Protection Act (CLCPA) and its grid reliability. Elected officials at all levels of government participated in round table discussions with business and nonprofit leaders.



GBEOP is the Chamber's 501c3 nonprofit organization that focuses on community leadership and education-workforce initiatives that help build a future talent pipeline for our local businesses.

BLI

- Twenty-four individuals graduated from the Broome Leadership Institute class of 2025 on March 27th, and the program celebrated 38 years. The BLI Class of 2025 completed a fundraiser and a service project for HCA. They raised over \$7,000, painted a classroom, and volunteered at the HCA's tasting event!
- Connected over 30 professionals with local nonprofit organizations for board opportunities at Speed Networking for a Cause

Youth Career Programs

- SPARK, a career exploration event for 8th graders, hosted 2140 students and 115 different careers with interactive activities.
- In partnership with Junior Achievement, the JA Inspire career exploration fair engaged 700 local students.
- Coordinated Junior Achievement programs in 41 classes, taught by 37 different business volunteers.
- BOCES New Visions completed the JA company program; developing InnoVision and donated their profits back to local mental health organizations.
- Participated in Manufacturing Days providing tours to over 200 high school students at local manufacturing sites during National Manufacturing Month.





BLI Alumni Association

- BLI Alumni sent out a survey to increase programming for the next year and are working on strategic planning for 2025-2026.
- The 2025 BLI Alumni Kids CAN build presented CHOW with over \$30,000 and engaged 10 school districts.
- The 2025 BLI Alumni of Distinction Award went to Chris Marion
- In July 2024 BLI Alumni had a picnic where 15 people connected at Otsinango park!

Workforce Development Programs

 GBEOP partnered with SUNY Broome to provide a 6-week management training for our Chamber businesses. 16 individuals participated from 14 different companies.

TOURISM



Visit Binghamton, Broome County's Tourism Promotion Agency is proud to represent an array of exciting events and attractions that highlight the unique charm and vibrant culture of Binghamton and its surrounding areas. From exploring the natural beauty of local parks and trails to experiencing the rich history and diverse arts scene, there's something for everyone to enjoy. Whether you're a local resident or a visitor from afar, we invite you to discover all that Broome County has to offer.

In 2024 we hosted 169 events which drew 66,795 visitors generating \$31.2 million in economic impact. In 2024 our golf package numbers continued to grow and for the first time ever, the impact of the program exceeded \$1 million in direct impact. Our marketing efforts were important for driving business. In 2024 we booked 7,991 rounds of golf and 2,890 hotel room nights generating \$1,003,925 in direct impact on hotel stays and golf rounds.

In 2024 I Love NY shared the 2023 Tourism Economic Impact report as commissioned by Oxford Economics. **Broome County tourism generated \$46,541,000.00 resulting in tax savings of \$572.00 per household.**

Our website, <u>www.VisitBinghamton.org</u>, continues to produce strong results and visibility. We ended **2024 with 312,276 page views (57% increase), 1,482 brochures downloaded (40% increase) and 208,060 new users (70% increase)!**



In 2024, our social media marketing saw impressive growth over the previous year. We reached over 255,000 people which was an increase of 9.9% from 2023. Content interactions stayed consistent at about 25,000 and our visits increased 14% as well as our link clicks with nearly 27% increase.

Visit Binghamton created 2 more videos in 2024 to add to our growing library of content. We were able to capture stories about DICK'S Sporting Goods and the John Hart Studio. The Visit Binghamton Film Office is an initiative under the Visit Binghamton & Greater Binghamton Chamber of Commerce umbrella.

Our Mission is to support filmmakers and production while shooting on-location in Broome County, while maintaining the best interests of community members. We are dedicated to driving economic growth in the region by providing resources and assistance with locations, permits, permission, crew members, and industry vendors.

Louis Newman continues to lead the Film Office efforts, and he has established working relationships with elected officials and local resources for the film industry while maintaining an emphasis on managing relationships with independent and studio producers.

- International exposure through industry events like the Glasgow Film Festival.
 - Stationed at Home, a feature film shot in Binghamton, made its world premiere at the Glasgow Film Festival to three sold out crowds raising our community's profile within the industry.
- Managing relationships with key decision-makers, location scouts, and producers to position Binghamton as a prime film location.
 - HBO, A+E Networks, Crown Media Networks.
- Development of a location reel and inclusion in the Destination Film Guide to boost regional visibility.
 - Working with filmmaker Chris Johnson to produce a marketing reel showcasing our variety of locations in a variety of seasons.
- Strategic partnership with Buchwald Agency to more strategically connect with motivated producers and industry professionals.
 - Helps the office tap into a network of industry decision-makers. The ability to leverage an agency's connections to connect with motivated producers further strengthens Visit Binghamton Film's potential to land impactful projects.
